- Council Members unanimously voted to accept the GNSAC By-Laws at 9:42 AM.

At 9:42 AM, Mrs. Reeves introduced Dr. Barry Byrne and his presentations on Krabbe Disease and Duchenne Muscular Dystrophy (DMD).

# **Overview of Infantile Krabbe Disease**

Dr. Barry Byrne presented on Infantile Krabbe disease at 9:44 AM.

- An overview of Krabbe disease was provided, which included:
  - Signs and symptoms
  - Treatment
  - Infantile Krabbe disease prognosis (if untreated)
  - o Long-term outcomes following umbilical cord blood transplant
  - Late Infantile Krabbe disease onset
  - Long-term outcomes following hematopoietic stem cell transplantation in late Infantile Krabbe disease

### **Krabbe Disease - Council Member Questions:**

- Dr. Zori questioned the screening method efficacy for Krabbe disease.
- Dr. Zori requested a more detailed presentation on Krabbe disease screening method efficacy.

- Mrs. Reeves announced the vote to add Krabbe disease to Florida's screening panel would take place at the February 2025 GNSAC meeting, a more detailed presentation will be provided at that time.
- Dr. Zori requested the presentation and materials on Krabbe disease be provided prior to the meeting for council member review.

# **Krabbe Public Comments**

Mrs. Reeves opened the floor for public comment regarding the presentation on Krabbe disease at 10:02 AM.

• Dr. Sanchez-Valle provided her experience as a geneticist when having to care for infants with Krabbe disease.

# Overview of Duchenne Muscular Dystrophy (DMD)

Dr. Byrne presented on DMD at 10:06 AM.

- An overview of DMD was provided, which included:
  - Benefits of screening
  - Signs and symptoms
  - Confirmatory testing options
  - Genetic testing
  - Gene therapy treatment options

## **Duchenne Muscular Dystrophy (DMD): Council Member Questions**

- Dr. Zori questioned if DMD screening was added to the federal Recommended Uniform Screening Panel.
- Mrs. Reeves informed the Council that the vote to add DMD to the RUSP was postponed until the winter Advisory Committee on Heritable Disorders in Newborns and Children meeting.
- George Fox provided comment on the early diagnosis and treatment to assist in extending lives for newborn screening conditions, even if the treatment is not perfect.
- Dr. Zori requested a more detailed presentation on DMD with informative handouts on the screening efficacy at an upcoming council meeting.
- Dr. Kleiner informed the council that next generation sequencing is needed for DMD testing. He then questioned if the laboratory staff could predict any impediments for testing that council members should be discussing.
- Dr. Zori commented that the state is closer to Krabbe disease approval than DMD and assessment on the readiness to implement screening and lab preparedness at next meeting.

### **Duchenne Muscular Dystrophy (DMD) Public Comments**

Mrs. Reeves opened the floor for public comment regarding the presentation on DMD at 10:50 AM.

 Dr. Sanchez-Valle provided insight that not every condition needs to be screened during the Newborn Screening test. There are other tests that can be done later in life that won't exhaust the newborn screening system.
